 - a) Two recent passport size and one stamp size photographs of the student.
 - b) Photo Copy of Aadhar Card each of the Student, Father and Mother.
 - c) A postcard size Family photo with the student.
 - d) One Copy of duly attested Date of Birth certificate issued by the Municipality/Block Office/Panchayat office in Form 5 or Form 9.
 - e) Medical history record in case of any sustained/prolonged medical case by Medical Officer
 - f) Blood Group certificate of the student.
 - g) Cast certificate for SC/ST and OBC
- III. Transfer Certificate/School Leaving Certificate (SLC) of the student from previous school in original and photo copy of Report Card (std. II onwards) on or before 01/04/25.
- IV. Total amount to be deposited as Admission Fee at the time of admission is Rs. 10,800/- (Ten thousand eight hundred only). Tuition and other fees will be charged from the month of April 2025.
- V. No payment will be accepted in cash at the fee counter.
- VI. No claim of admission of your ward will be entertained after the lapse of the due date of admission.
